COMMITTEE REPORTS

a. Executive Committee: Grants

1. Program, Arts Education, and General Operating Grant recommendations

OVERVIEW

The Arts and Culture Trust Fund Committee received a total of 72 applications for Program Grants, Arts Education Grants, and General Operating Grants. The following training sessions were given to the public, to assist with the application process:

- A pre-recorded application tutorial, offering step-by-step instructions on how to complete each of the aforementioned applications
- 6 hours of "open office" sessions, where applicants could ask questions in person or online via Zoom
- A virtual "Budget Power Hour" where applicants could ask all budget related questions
- A pre-recorded budget overview explaining each line item.
- A pre-recorded instructional video for ADA Plans and Grievance Procedures
- A training session on ADA and Accessibility, presented by the Cultural Access Network

All sessions were recorded and made available online at jerseycityculture.org

The Program, Arts Education, and Operating Grant applications were made available in 60+ languages and met Tier 2 AA accessibility requirements.

72 applications were submitted, deemed complete, and moved onto evaluation by the Grant Review Panel.

STATEMENT OF CONFLICT OF INTEREST POLICY

Members of this Jersey City Arts and Culture Trust Fund Committee have joined with the understanding of the Committee's Conflict of Interest Policy. We want to take a moment to acknowledge this policy:

According to Ordinance 21-030 of the Jersey City Municipal Code, Chapter 304, Article 9:

A voting Committee member may not sit on the Board of Trustees or be on staff of an organization who is applying for a grant during this grant cycle. Members agree not to engage or enter into any contracts that pose a conflict of interest, or they shall end their tenure with the Committee. Awardees are listed by groups and anyone wishing to recuse themselves may do so when the group is called.

PROGRAM GRANTS

We will begin with Program Grants. There are a total of 45 awards. The Grant Review Panel has scored these applications on a scale of 0-100. The Committee recommends grant award distribution based on these final scores, with the applications receiving the highest scores receiving full funding.

Those Applications receiving scores of 80 to 100 points are recommended for full funding.

Applications receiving scores of 70-79 points are recommended for 75% funding.

Applications receiving scores of 59-69 points are recommended for 50% funding.

Based on this breakdown, I will now ask the Committee to vote on funding.

INDIVIDUAL ARTIST GRANTS

2. Individual Artist Fellowship recommendations from the Jersey City Arts Council

Co-Chair: I now call the Jersey City Arts Council to present on the Individual Artist Fellowship program, a sub-grant of the Jersey City Arts and Culture Trust Fund.

Jersey City Arts Council:

The Jersey City Arts Council had a total of 155 fellowship applications. 151 of these were deemed complete and moved on to the evaluation stage by the Grant Review Panel.

The JCAC Board considered the applications recommended for a fellowship by the Grant Review Panel (46 applications out of a total 151 submitted applications). Applications that were recommended by more than one reviewer were added to the Final IAF Recommendations list (14 applications). Then the JCAC board looked at the total scores from reviewers for the recommended applications, and selected the highest scoring applications. Additional consideration was made to include diversity and representation across the Wards of Jersey City (while still using the scores of the review panel). This final list of 20 applications are the JCAC Board's recommendations for an Individual Artist Fellowship.

We are proposing 20 artists for Fellowships for 2023-2024 fiscal year
